Learning outcomes	The course introduces to the major theoretical issues and significant currents of philosophical thought from Kant to the present, through the study of selected texts and literature, and explores a theme, a text or an author of particular importance for the history of contemporary philosophy, through critical analysis of works, of methodological issues and of more meaningful interpretations.
Course contents	The Transcendental Aesthetic and the Transcendental Analytic of Kant's Critique of Pure Reason. The first part of the course will discuss the key issues and the most important philosophers in the history of philosophy from Kant to Nietzsche. The second part of the course – monographic in character - covers

reading and discussion of the two mentioned parts of Kant's work,

taking into account the historical origin of the problems discussed, and also in reference to some of the most significant interpretations developed later.
